Unyeway, Inc. provides Day Program Services in Lakeside and Chula Vista California as well as Community Employment Services throughout San Diego County. Unyeway, Inc. also operates a retail nursery in Ramona. Unyeway, Inc. has a Production Center and Activity Center in Ramona, California. Unyeway, Inc.'s Day Programs in Lakeside provide Behavior Management Services, Nursing Services, Community Based Programs, Adult Development Center Programs, and an Activities Center. Unyeway, Inc.'s Chula Vista location provides Behavior Management Services, Nursing Services, a Community Based Program, and Adult Development Center Programs. Our Community Employment Services provide Individual Placement, Group/Enclave Placement, and Habilitation Programs. In the 2018-2019 Fiscal Year Unyeway, Inc. provided services to approximately 365 San Diego County participants. Unyeway Inc. contracts with a Consulting Psychologist for specialized services for our participants. Unyeway also employs LVNs for participants with medical needs.
